Advisory Chair Appointment

Advisory Chair Role

Working in the context of the BHG Group and SSE Central Board agreed strategies, and reporting to the BHG CEO Claire Dove OBE, the Chair would be responsible for:

- •Recruiting members to their Advisory Board in conjunction with the CEO, Head of SSE NW and either the Chair or Deputy Chair of the Group Board
- •Supporting, challenging and extending the reach of the Head of SSE NW leveraging their contacts and networks to enable the school to achieve its goals and grow its work in a sustainable way
- •Assuring the CEO and Group Board that the SSE contract and requirements of the license/contract are being met escalating good practice, risks and concerns to the CEO in the first instance
- •Acting as an ambassador on behalf of the SSE and BHG promoting our work and the interests of our students and bringing in contacts and resources to help
- •Where requested /agreed- representing the SSE on behalf of the Group
- •To keep up to date with the SSE operating environment and national contract conditions to help ensure BHG and the SSE NW are working as an exemplar in this field

Advisory Chair Role

SSE North West wishes to recruit a Chair who will bring the following:

- •Evidence of impact in governance and or advisory role
- •Insights, networks and connections into fields that would help to advance the SSE and our students' business interests
- •Business acumen and experience of start ups, scale ups and growth of sustainable larger scale enterprises

It is anticipated that this role is likely to involve a commitment of time of between 10 and 12 days per year including

- •Liaising with the CEO of BHG as required and meeting with the CEO and or BHG Chair or her nominee on a quarterly basis
- •Maintaining contact/offering support to your fellow Advisory Board members
- •Chairing meetings on a bi-monthly basis
- •Liaising with the Head of SSE NW on a monthly basis
- •Participation in the SSE Network Board Calls
- Undertaking externally facing activities
- Participating in development events
