

Fellows Future Fund

Introduction

Round 8 of the Fellows Future Fund will invite applications from SSE fellows who graduated from their most recent SSE programme at least 12 months ago. Once again, rather than set a theme, we want **you** to tell us what you need and how funding and mentoring support will help you build more sustainable organisations and impact.

In addition to mentoring, we'll be offering 3-4 grants of £7,500 this round.

Eligibility

The Fellows Future Fund is open to Fellows of SSE programmes:

- That lasted more than six months,
- That ended at least 12 months ago (not counting follow-on support)

Even if you have attended multiple programmes, **the most recent programme must have ended at least 12 months ago**. You **cannot** currently be on a long-duration programme, nor can you be accepted to one starting later this year. There are exceptions for those on 'follow-on' programmes.

- Your organisation must be a social purpose organisation that has a restriction on profit, so that most profits are returned for social purposes, and is asset locked.
- It must be based in the UK but could be active anywhere in the world.
- Your organisation must be established, with at least £25,000 income in the last year. If Covid severely affected your income, please get in touch (charlie.wright@sse.org.uk).

The Criteria

We want you to tell us what you need, and what would make a difference to your organisation right now. Here are a few more details:

- Please propose an idea for a project or initiative that will be completed within a 12-month grant period.
- You'll be asked to tell us about your organisation, and how the idea you're proposing could support resilience and sustainability both in terms of your business model and the impact that you have.

Please note, that the Fellows Future Fund grant **cannot** go towards unrestricted funding for your organisation. If you are proposing to hire new staff with the grant, they should have a specific remit of work that will make a significant difference to your organisation and beneficiaries.

We will assess applications by the extent to which they meet the following criteria:

- There is significant and measurable need for the proposed project, •
- The organisation is focused on building a sustainable business model and the proposed idea can contribute towards its financial resilience,
- The proposed idea is feasible and can be completed within a 12-month period,
- The proposed idea will have a significant impact on beneficiaries, communities, • and the sector-at-large.

Application Process

We believe all ideas can be improved by feedback from multiple perspectives, so this assessment process is structured to provide plenty of opportunities for feedback and interaction with the Social Partners - the group who assess these grant rounds.

Stage One: Online Application

You'll fill in some basic information, and you'll answer a series of short-answer questions about your organisation and the proposed initiative. Online applications are open between February 7th and February 21st.

Once the deadline for submissions has passed, we will longlist a group of up to 28 applicants to advance to the next stage.

Stage Two: Shortlisting Rounds

Longlisted applicants will be invited to take part in one of 4 virtual Shortlisting Rounds.

If you are invited to a Shortlisting Round, you'll be provided with a 15 minute timeslot, during which you will be able to discuss your idea in more depth. You will also receive direct feedback and questions from the Social Partners.

Shortlisting Round Schedule*:

- 1. Thursday 3rd March, 09.30 12.30
- Friday 4th March, 13.30 16.30
 Monday 7th March 09.30 12.30
- 4. Monday 7th March 13.30 16.30

*You'll be invited to attend one of these dates and will only be required to attend a slot of approximately 15 minutes. You will be able to indicate your availability when you submit your initial application.

After all four Shortlisting Rounds have taken place, 8-10 finalists will be shortlisted and invited to a final pitching panel.

Pre-Panel Prep

If you are invited to the final pitching panel, you will be asked to submit a fuller, final application that includes your official full accounts, and a project plan. You'll be able to change and refine your idea and your pitch based on the feedback you received during the Shortlisting Round.

Stage Three: Pitching Panel

We will hold a virtual pitching panel on April 1st, 2022. If invited to the final pitch, you'll be given another timeslot, during which you'll pitch and then take questions from the

panel of Social Partners. After the final pitching panel, 3-4 grantees will be selected by the Social Partners to receive £7,500¹ and mentoring support from Social Partners.

Appendix A - Criteria Guidance

- 1. There is significant and measurable need
 - Have you clearly articulated the issue that needs to be addressed with a few relevant facts/figures/statistics?
 - Have you demonstrated why it is important to undertake this project at this time?
- 2. The organisation is focused on building a sustainable business model and the proposed idea can contribute towards its financial resilience
 - Have you told us which aspects of your current income streams are sustainable and/or commercially viable?
 - Have you considered and demonstrated how the initiative might bring in additional revenue and/or become self-sustaining?
 - Do you have a realistic plan for sustaining the initiative after the grant period ends?
 - Have you provided an analysis of the costs and benefits of the project?
 - You might not have this figured out just yet and that's fine! we want to support organisations who want to build towards this vision. Make sure you provide information on what challenges you face in establishing a sustainable business model and how targeted mentoring support could help with this.

3. The proposed idea is feasible

- Does the idea you have proposed effectively respond to a need or issue?
- Is the project aligned with your organisation's mission and purpose?
- Is 12 months a reasonable timeframe for progress with this initiative?
- What risks have you identified and how will these be addressed?
- Have you done any background work on this project such as market research?
- 4. The potential impact on the organisation and beneficiaries will be significant.
 - Does your organisation have a robust track record of impact that the project will build on?
 - Have you articulated how the initiative will tangibly make a difference for beneficiaries, communities, the environment, and/or your sector?
 - What other actors, existing research, or good practice could be called upon to ensure the success of this project? Have they been identified?
 - Tell us about the change you have been able to create in your community and

what you have been able to achieve against these benchmarks. For example "through our programme, X number of people have secured long-term employment" or "our programme reduces re-offending by Y% as compared to other programmes".

• Avoid just talking about organisational achievements such as awards.
