# **About the School for Entrepreneurs**

We can't fix issues like poverty, climate change and ill-health alone. That's why the School for Entrepreneurs exists. SSE helps 1,000 people a year develop the skills, strengths and networks they need to tackle society's biggest problems. It runs courses that equip people to start, scale and strengthen organisations that make a positive difference. But it is not a traditional school. # **Role Purpose**

You will play a pivotal role in designing and delivering high quality support programmes for social entrepreneurs in communities across the UK, and in recruiting them to participate in SSE's programmes.

The support you design and deliver, both in-person and online, will empower social entrepreneurs to set up and grow organisations that have social or environmental benefit, and will contribute to their leaders' development as change makers.

You will work closely with the Entrepreneurship Delivery Leads, fellow Entrepreneurship Facilitators, Entrepreneurship Support Leads, Administrators, and freelance business coaches and experts.

You'll have a specific focus on supporting the Entrepreneurship Delivery Lead (with Digital Specialism) to scout out the latest innovations in digital learning and embed them into our practice at SSE.

# **Key Responsibilities**

#### Find and recruit the UK's most promising entrepreneurs

- 1. Build relationships with local and grassroots community partners working with entrepreneurial talent and undertake outreach to ensure SSE is fulfilling its mission in yielding diverse pools of talented applicants.
- 2. Design and deliver innovative candidate assessment activities that bring out the best in the talent that applies for SSE's programmes, successfully identifies and tests promising entrepreneurial talent that could best benefit from SSE's programmes and minimises unconscious bias that may disadvantage minoritised applicants.
- 3. Work with the Impact Lead and Entrepreneurship Support Leads to review application data, and develop plans for turbocharging the quality and diversity of future candidate application pools for SSE's programmes

### Design and deliver SSE's innovative support for entrepreneurs

- 4. Work with Entrepreneurship Delivery Leads and fellow Entrepreneurship Facilitators to design programmes that support SSE's entrepreneurs and their ventures to build their capacities for social impact generation and commercial success.
- 5. Deliver 1-2-1 sessions, such as entrepreneurial diagnostics and enterprise coaching sessions, to support our entrepreneurs to develop commercial and impact goals and provide 'critical friend' accountability as they work towards them. 1-2-1 sessions should include pastoral and wellbeing support in line with SSE's Health and Wellbeing Strategy, where appropriate.

- 6. Deliver group sessions for cohorts of entrepreneurs, for them to grow their capacity for impact and commerce by drawing on the insights of their peers, and 'learning by doing' rather than 'learning by viewing'. Session themes would include financial management, business modelling, impact measurement, marketing, team development.
- 7. Deliver Action Learning Sets, a peer coaching method long-embedded in SSE's programmes, having received training from experts in how to best facilitate this powerful intervention.
- 8. Support the planning and delivery of events for SSE's entrepreneurs, including sessions for graduates of SSE's programmes (SSE Fellows).
- 9. Working with the colleagues across the Entrepreneurship Directorate, contribute to the development of robust monitoring and evaluation systems for SSE's programmes, and use impact data to improve the effectiveness of the support provided to entrepreneurs

#### Build SSE's digital learning expertise and infrastructure

- 10. Build internal knowledge and expertise around digital learning methodologies and tools, drawing on global best practice approaches to support SSE' entrepreneurs to innovate
- 11. Support the development and delivery of SSE's digital transformation projects in the delivery team, including our new Virtual Learning Environment.
- 12. Contribute to SSE's bank of entrepreneurship support resources, including activity plans and session plans, which are shared across SSE's family of Entrepreneurship Facilitators for the benefit of entrepreneurs across the UK and internationally.

# Job Applicant Privacy Notice

As part of any recruitment process, SSE collects and processes personal data relating to job applicants. We are committed to being transparent about how it collects and uses that data and to meeting its data protection obligations.

# What information does SSE collect?

SSE collects a range of information about you. This includes:

- your name, address and contact details, including email address and telephone number;
- details of your qualifications, skills, experience and employment history;
- whether or not you have a disability for which the organisation needs to make reasonable adjustments during the recruitment process; and
- information about your entitlement to work in the UK;

SSE collects this information in a variety of ways. For example, data might be contained in application forms, CVs or resumes, obtained from your passport or other identity documents, or collected through interviews or other forms of assessment.

SSE will also collect personal data about you from third parties, such as references supplied by former employers. We will seek information from third parties only once a job offer to you has been made and will inform you that it is doing so.

Data will be stored in a range of different places, including on your application record, in HR management systems and on other IT systems (including email).

# Why does the organisation process personal data?

SSE needs to process data to take steps at your request prior to entering into a contract with you. We may also need to process your data to enter into a contract with you.

In some cases, SSE needs to process data to ensure that it is complying with its legal obligations. For example, we are required to check a successful applicant's eligibility to work in the UK before employment starts.

SSE has a legitimate interest in processing personal data during the recruitment process and for keeping records of the process. Processing data from job

applicants allows us to manage the recruitment process, assess and confirm a candidate's suitability for employment, and decide to whom to offer a job. SSE may also need to process data from job applicants to respond to and defend against legal claims.

For some roles, SSE is obliged to seek information about criminal convictions and offences. Where the organisation seeks this information, it does so because it is necessary for us to carry out our obligations and exercise specific rights in relation to employment.

SSE will not use your data for any purpose other than the recruitment exercise for which you have applied.

# Who has access to data?

Your information will be shared internally for the purposes of the recruitment exercise. This includes members of the HR and recruitment team and interviewers involved in the recruitment process.

We will not share your data with third parties, unless your application for employment is successful and it makes you an offer of employment. SSE will then share your data with former employers to obtain references for you.

SSE will not transfer your data outside the European Economic Area.

# **How does SSE protect data?**

SSE takes the security of your data seriously. It has internal policies and controls in place to ensure that your data is not lost, accidentally destroyed, misused or disclosed, and is not accessed except by our employees in the proper performance of their duties.

# For how long does SSE keep data?

If your application for employment is unsuccessful, SSE will hold your data on file for 12 months after the end of the relevant recruitment process. At the end of that period your data is deleted or destroyed.

If your application for employment is successful, personal data gathered during the recruitment process will be transferred to your personnel file and retained during your employment. The periods for which your data will be held will be provided to you in a new privacy notice.

# Your rights

As a data subject, you have a number of rights. You can:

- access and obtain a copy of your data on request;
- require SSE to change incorrect or incomplete data;
- require SSE to delete or stop processing your data, for example where the data is no longer necessary for the purposes of processing;
- object to the processing of your data where the organisation is relying on its legitimate interests as the legal ground for processing; and
- ask SSE to stop processing data for a period if data is inaccurate or there is a dispute about whether or not your interests override SSE's legitimate grounds for processing data.

# What if you do not provide personal data?
