Introduction to the School for Social Entrepreneurs and City Bridge Trust.

Established 1997, the School for Social Entrepreneurs (SSE) exists to support people to use entrepreneurial approaches to tackle complex social and environmental problems. We run programmes that support over 1,000 people to develop the skills, strengths, and networks they need to start, scale and strengthen social enterprises. Our regional teams work across the UK and internationally. Our approach is practical and inclusive - participants develop soft skills such as confidence through learning in cohorts and develop business acumen and life skills by applying their learning directly to the project they are establishing or leading. Our programmes are highly tailored to specific needs, offering a blend of enterprise learning, innovative funding (Match Trading™ or traditional grants) and mentoring.

City Bridge Trust is London's largest independent charitable funder, awarding grants of more than £30 million a year to support the people of London. They provide grants and use their resources to help communities foster connections, become more resilient and build a more equal London.

Programme overview

Do you lead a social enterprise which meets local needs within Greater London? Are you trading effectively, but now need to scale up to the next level?

The Community Growth Scale Up programme is supported by City Bridge Trust, the City of London Corporation's charity funder, in partnership with the School for Social Entrepreneurs.

The learning programme has 10 places and will feature 8 learning days from September 2023 - July 2024. The programme is designed to assist leaders to significantly grow their social enterprise, increase income, resilience and impact. The programme will support leaders to

develop new skills and get support from other leaders, plus a Match Trading grant of up to £10,000 which will challenge you to increase your trading.

We are looking for social enterprises that have realistic plans to significantly scale up their social impact to benefit Londoners (i.e., people whose main residence is in one of the 32 boroughs or in the City of London). You may be:

- Looking to move from working "in" to working "on" your project.
- Wanting support to lead a growing team.
- Developing significant new projects or services
- Extending the geographic reach of your social enterprise by providing services in new areas within Greater London

This programme could help you:

- Learn how to strengthen your project and increase your impact through a package of support from Sept 2023 to July 2023 including 8 learning sessions with other social entrepreneurs (4 sessions in person, 4 online).
- Fund your growth plans with a Match Trading grant of up to £10,000.
- 1:1 action clinics with your facilitator throughout the programme
- Opportunity to attend a 1-hour online development support panel session
- Access a diverse network of social entrepreneurs, who will support your plans and help you through tough times.
- Collaborate and build a relationship with SSE and its wider fellows' network.

Opportunity to shape our new Trading for Good Portal.

With City Bridge Trust's support, SSE is developing an exciting new portal which will help SSE and other funders to connect with social enterprises to support their trading. We will be asking participants on the Community Growth Scale Up programme to contribute to the development of this portal through testing, getting involved in focus groups and telling us about their experiences. All participants on the Community Growth Scale Up programme will have the opportunity to contribute to the development of this exciting new approach, through testing elements of the new portal and contributing to our user experience research. This will be a unique opportunity to help SSE strengthen the body of evidence to make a case for support for social enterprise in London.

Witness Sessions

Entrepreneurs share their experiences and discuss the secrets of their success. You will be able to listen, learn and question them to help you examine and find meaning for your own project.



Expert Sessions



Through questioning, observing and listening to experts, you will improve your abilities in financial management, income generation, business planning, sales and marketing, managing people, partnering and other essential skills.

Peer Support

You will bring your skills and experience to the group and learn from the skills and experience of the other members. This network of likeminded people will provide vital support to enable you to developyour enterprise.

A grant to help you get your project off the ground or to grow your organisation.



Match Trading™ Grant



Your social enterprise will also receive a Match Trading™ grant of up to £10,000. This grant is designed to challenge you to grow your trading income. Match Trading has been proven to increase income from trading and boost resilience. Your social enterprise will receive £2000 up front, and then 4 instalments of up to £2000 over the year matched against your increased trading. To claim the full grant, you will need to show that your trading income has increased by £10,000 over the year.

Your grant can be used flexibly, helping you to attend the programme and to put your learning into practice by developing your trading and community business. <u>Visit the Match Trading website for more details</u>.

What can I spend the grant on?

Our intention is to be flexible as possible about how you spend the grant, but it must be used to support your learning and to put that learning into practice through developing your social enterprise.

Is my social enterprise eligible?

You must be **committed to and working towards** meeting the City Bridge Trust criteria:

- Your work must mainly benefit Londoners. Londoners are people whose main residence is in one of the 32 boroughs or in the City of London. If your social enterprise is based outside of London, but your work mainly supports people living in London, then we would consider this.
- Trading for the benefit of the local community. Your work must be trading or planning to trade with profits reinvested in the community or to support activity in the community in one or more of the following main themes:
- > Children & Young People
- > Refugees, migrants and asylum seekers
- Disabled people
- > Older people
- > Tackling abuse, exploitation and hatred
- Criminal justice
- Mental health services
- > Advice and support services
- > Improving access to education or employment
- > Improving health and wellbeing
- Voice & leadership
- Food poverty
- Greener London
- Access Improvements
- Infrastructure support

• Scale up stage

Your social enterprise must have an income of £50,000 in the last financial year or the last 12 months. This can be any income, including grants and donations.

It should have advanced plans to significantly grow its impact over the next year, including plans to increase trading.

• Leadership team

You must have at least two people on the board of your social enterprise. We cannot accept applications from sole traders.

We are particularly keen to support social enterprises who are led by Black and Minoritised communities, disabled people and LGBTQIA+ communities and people with lived experience of the issues their social enterprise is addressing.

Governing document

Your social enterprise must be currently active, and have a constitution, set of rules or legal structure. Your community business may be a registered charity, a Community Benefit Society (CBS) or a Community Interest Company (CIC).

We can also accept other companies, co-operative societies or unincorporated associations, if they have certain clauses in the governing document, specifically:

- a) a social purpose,
- b) a restriction on distribution of profits, which means that 51% or more of all of profits are returned for social purposes and,
- c) an asset lock or winding up clause which means that if the social enterprise is wound up, its remaining assets go to a charity, CIC or other asset locked body.

Committed to learning

The applicant should be a leader in your social enterprise, with some strategic control, usually the CEO, the founder, a director, or a board member. You must attend at least 80% of the course sessions.

• Bank Account

You must have a bank account in the legal name of your social enterprise managed by at least two unrelated people who release payments, OR an account where the participant has sole control.

Other

All social enterprise leaders taking part in the programme must have the right to work in the UK and must be aged 16 or over by April 2023.

Making an application

Apply by 12pm on Friday 23rd June 2023.

As part of the application, we ask you to provide your most recent annual accounts if available, and your safeguarding policy if you have one.

If possible, please also provide a copy of current income and expenditure for this financial year, and any useful documents about your impact, such as a case study or impact report if you have one.

- Go to the Application form- this is your personal invitation to apply, please do not share this link with others
- You can save your application and return to it at a later date. Just click "Save for later", and you will be given a unique link to return to your application.
- When you've completed all the questions, click "Preview" to review your application, then click "Submit". You will be redirected to our equalities monitoring form and you will also receive a copy of your application by an email from 123 Formbuilder. Check your junk folder if you can't find the email.

Please don't submit your application after 12pm on Friday 23rd June 2023 as it will not be considered. Under exceptional circumstances, we may give approval to submit your application late. To arrange this, you must email Claire Dever ahead of the deadline on claire.dever@sse.org.uk.

Accessibility and our commitment to inclusion

We recognise that discrimination of all sorts infiltrates every part of our society, and we are working hard to counter that wherever we find it. Frequently Asked Questions

- 1. Can I apply if my work benefits people outside of London? This is a London focused programme. Your work must mainly benefit Londoners. Londoners are people whose main residence is in one of the 32 boroughs or in the City of London. If your social enterprise is based outside of London, but your work mainly supports people living in London, then we would consider this.
- 2. Can I apply if I have been on an SSE programme before or am currently on an SSE programme?

You can apply if:

- You have attended previous SSE programmes.
- You have applied to SSE before and were unsuccessful.
- You are on a current SSE programme which ends before 30th August 2023
- 3. Can we apply if our social enterprise has people that are connected to SSE or the City Bridge Trust?

If your social enterprise is run by people who regularly work for or are trustees of SSE, or The City Bridge Trust or have a close financial or family connection with staff or trustees, please contact us before making an application to ensure that there is no conflict of interest.

4. What if we have particular needs, which may prevent us from fully taking part in the learning programme?

We are keen to enable people with disabilities and other access issues, to join our programmes. There is a separate small fund held by SSE to enable students who have particular needs to access the programme. This will be negotiated individually with participants. If you have specific needs and are concerned about this, please contact us to discuss.

5. What happens if my project will work with children under 18 or vulnerable adults?

You will be required to provide a Safeguarding Policy and may need enhanced DBS checks for staff and volunteers.

6. How does Match Trading work?

7. Can I apply for this programme if I have criminal convictions?

Previous SSE Fellows have included people who have criminal convictions, some of whom have used their experience in prisons to make a difference to the lives of ex-offenders. You do not need to let us know about previous convictions unless they are relevant to your application.

If you have unspent convictions for fraud or any convictions which may affect your ability to run your social enterprise, including working with children, young people or adults who

are vulnerable, you must let us know, as we may undertake checks during the application assessment.

8. What about Data protection?

SSE has a Privacy Policy which is available here. SSE also has a Data Protection Policy. We are committed to protecting your personal information and acting in accordance with your rights under the Data Protection Act 1998. We may need to share your information in order to undertake assessment of your application, statistical analysis, research and monitoring, compliance and regulatory reporting and fraud prevention. We may share your information

- with our funders
- with our agents or subcontractors for operational reasons
- with other agencies in order to assess your application
- with others for the purpose of compliance and regulatory reporting and to confirm your identity for money laundering purposes and fraud prevention
- if compelled to do so by law.
